JOB SUMMARY: Provide support to UPL's North American Research and Development department which includes initiation and completion of special projects as well as working with UPL's Technical Services Team to monitor research trials and take samples for critical data related to product advancement and supporting UPL's Sales and Marketing teams.

REQUIRED EDUCATION AND EXPERIENCE:

- Currently pursuing a bachelor's or higher degree in Agronomy, Entomology, Plant Pathology, Weed Science, Soil Science and/or related field.
- Must be a self-starter with the ability to work in a team environment.
- Must be able to take remote direction.
- Must possess the ability to work within a highly regulated area.
- Detail oriented, troubleshooting, and analytical skills required.
- Strong written and verbal communication skills required.
- Proficient Microsoft Office skills required including word, Excel, PowerPoint, and Outlook.

JOB RESPONSIBILITIES:

- Routinely walking, scouting, sampling, and working in production orchards and crops in varying summer elements throughout the Midwest.
- Support the Technical Service Managers and Lead with weekly field observations and updates.
- Ability to use GoPro and digital camera to document observations and transfer those files weekly.
- Scout assigned customer fields throughout the year.
- Ability and comfort handling crop protection products in agricultural environments.
- Willingness to understand and follow PPE requirements when necessary.
- Travel long distances between research trials for observation.
- Ability to acquire drone FAA certification
