Formatting Change

Final format phase completed

The format transition that began in Spring 2016 from requirements set in the 1920s is now complete. Pagination placement has changed and the abstract "reference block" has been eliminated.

New format requirements allow students to choose a printer vendor without the stress of needing to reformat their thesis.

Updated Word Templates

The TDO strongly recommends that students use the templates that are available on the **Templates** webpage. The templates that are published to this page contain all up-to-date requirements. Upcoming improvements to the Templates website will allow students to choose their department and the template designed for their department will appear to download. No more guessing which template to use!

Puthesis Template

The TDO is still accepting all theses and dissertations that are formatted using the old puthesis template. The new puthesis template will be available in the near future after extensive testing and will reflect current formatting requirements.

Discoverability

Hammer began indexing with Google Scholar in March 2019. The repository is also indexed with the Networked Digital Library of Theses and Dissertations (NDLTD). Metadata record integration with ProQuest is on the horizon.

Since publishing began in December 2018, there have been over 57,000 views and over 17,000 downloads of theses published to Hammer.

Are you planning to use previously published or copyrighted material in your thesis? You may need to request permission to reuse the material!

Copyright Permission Letters

an article that you have writen or you are using someone elses copyrighted works within your own thesis, you will likely need to request permission to reuse the material.

examples of copyright permission letters.

Fair Use vs. Permission

If you have signed away the copyright to According to Purdue's University Copyright Office, "Fair use is one of the exceptions in copyright which allows use of copyrighted materials without obtaining permission as along as the use can be considered fair"1.

Visit this website, which provides helpful Follow the Fair Use guide here to help determine whether reuse of copyrighted material can be considered as Fair Use.

Publisher/Journal Requirements

Each academic publisher or journal has different requirements on the reuse of publications or prepublications. It is helpful to read the author agreement forms that you sign before publishing with the journal as these agreements normally have guidelines on what you can and cannot do with the article that you are submitting/have submitted/plan to submit.

Format Consultations

Schedule a format consultation to relieve the formatting stress!

Let the formatting experts in the Thesis and Dissertation Office help with your formatting! contents? Something else? Trust us to help set you on the right track BEFORE you defend your thesis!

The Thesis Office staff recommend that students schedule a format consultation before they submit their manuscript to their committee for their final defense. We will ensure that the students are properly formatted, which reduces the number of revisions that are asked from the students at deposit time.
