Sem. 1, 2 and 3, Lecture 1, Cr. 1.
Prerequisite by Topic:

Description: This course introduces the key concepts of equilibrium statistical mechanics leading to the celebrated Boltzmann law and how it leads to Boltzmann machines and related concepts in modern machine learning. No prior background in statistical mechanics is assumed.

Reason: This course is intended to be broadly accessible to students in any branch of science or engineering who would like to learn about the conceptual framework for equilibrium statistical mechanics, its application to modern machine learning and the relation to quantum computing.
